Fellow Residents:

There is no meeting scheduled for May 2018 at this time.

IMPORTANT REMINDERS – Communication is Key. Thank you in advance.

Please see Covenants Article VII as well as the additional guidelines for further details. You will find both on the web site. You have an obligation to keep your property in good aesthetic condition.

1. **HURRICANE Repairs/Replacements** – Homeowners: Many homes are in need of repairs/replacements of roofing, fencing, painting home & other miscellaneous items like soffits & fascias. There is a timeline as noted in the covenants for this to take place. While the HOA Board understands problems with contractors and insurance companies – To avoid violations, those whom have not completed these important repairs need to let the HOA Board know of your intentions and timelines. Fallen fencing needs to be removed off the ground and put back up in good repair or removed entirely. Soffits & fascias missing need to be replaced and put back in good repair as intended. If your home needs painting, this also needs to be taken care of. Please submit your ARC applications for your projects. Homeowners: Please remember you must **submit ARC applications to obtain approval** to an ARC member **before** beginning work (instructions & forms are found on the ARC page of the web site at – regencyplacehomeowners.com). Page 3 includes instructions on how to submit your applications. Call the HOA at 863-420-7799 with your concerns & questions.
2. **YARDS** - Please attend to yards by keeping them green, replace dead areas of grass as needed, maintain pest control, edge along the driveway and curb areas as well as remove and treat for weeds. Regular mowing is required to keep grass no more than 6 inches high. Please clean up and maintain your property per covenants to avoid violations.
3. **GARBAGE CANS** - As a reminder you must store your **garbage/recycle carts** and other non yard items out of sight, such as in the garage or to the rear of the home specifically “behind your home”. Garbage/recycle carts may only be out on day of pickup.

OTHER IMPORTANT INFORMATION -

1. **PETS** – **Thank you to all responsible pet owners!** You are much appreciated. Many pet walkers have been spotted not following the rules for Polk County & Regency Place. Your pet must always be on a leash. You may not allow your pet to do their business upon any residents' lawns. You are trespassing when doing so. The only common area allowed for pet walking is behind the pool parking lot – not in residents' yards and not at the PLAYGROUND. You must still pick up after your pets and take your doggie bag home to your trash can. For the healthy sake of everyone especially children - do not leave the bag at the pool area.
2. **POOL** – The pool gate is now automatically opening 8 am and closing at 8 pm. Please leave the pool area before the gate auto locks at 8 pm for pool licensing.
3. **PARKING** – Please remember to fill out an overnight parking form for the pool lot. This parking is for temporary overnight parking. There shall be no vehicles on the street between the hours of 11 pm and 7 am for emergency services to access the roads easily. There is also no parking on grassed areas anywhere in Regency Place. Violations and towing of your vehicle does apply.
